Since 1996 the investment, construction of the operation of facili-ties necessary and essential to accommodate the public on fee sim-ple lands near Martins Cove was provided by the LDS Church. And I want to commend the BLM for permitting treks across its land from 6th Crossing west to Rock Creek and for working coop-eratively with the LDS Church in recent years to facilitate public access to this historic site. Its unfortunate that some of the media, Mr. Chairman, has pur-posely tried to malign the LDS Church because of its effort to ob-tain Martins Cove. Congress has previously offered the sale...
